

## ARTICLES OF INCORPORATION

We, the undersigned, incorporators, hereby associate ourselves together to form and establish a corporation NOT FOR PROFIT under the laws of the State of Kansas.

**ARTICLE ONE:** The name of the corporation is Kansas Chapter of Public Risk Management Association.

**ARTICLE TWO:** The address of the registered office is 5401 S. W. Seventh Avenue in the City of Topeka, County of Shawnee, 66606. The name of resident agent at the above address is Mary A. Goodman.

**ARTICLE THREE:** This corporation is organized NOT FOR PROFIT and the nature of corporation business or purposes to be conducted or promoted are:

1. To increase the proficiency of risk management in governmental entities and intergovernmental risk pools;
2. To strengthen the quality of risk management through continuing education;
3. To be an educational and research organization for the benefit of governmental entities and intergovernmental pools throughout the State of Kansas;
4. To provide members the opportunity to exchange ideas and to consult with one another and to meet with persons in or associated with public risk management and to supply members with information concerning their organization, Public Risk Management Association;
5. To support the mission and goals of National PRIMA as documented in its Strategic Plan; and
6. To act in any other manner which will further the best interests of governments, governmental agencies, intergovernmental risk pools, school and other special districts in their risk management activities.
